## Amendment No. 1 to Cooperative (LPA) Agreement No. P450-16-063

This Amendment is made and entered into on June 8, 2018 between the State of Nevada, Department of Transportation, hereinafter referred to as the "DEPARTMENT," and the City of North Las Vegas, 2250 North Las Vegas Blvd., Suite 610, North Las Vegas, NV 89030, hereinafter referred to as the "CITY."

## WITNESSETH:

WHEREAS, on August 16, 2016, the Parties entered into Agreement No. P450-16-063 for the construction of fiber optic ITS conduit and cable including management software on Centennial Parkway, Ann Road, Aliante Parkway and Martin Luther King Boulevard; and

WHEREAS, this Amendment No. 1 is needed to increase the amount of funding under Agreement No. P450-16-063 by Four Hundred Seventy-Three Thousand Six Hundred Eighty-Four and No/100 Dollars (\$473,684.00) due to the Regional Transportation Commission of Southern Nevada's (RTC's) approval of CITY funding for an additional Four Hundred Fifty Thousand and No/100 Dollars (\$450,000.00) of Congestion Mitigation and Air Quality (CMAQ) funds; and

WHEREAS, the CITY has requested and been approved for a change in the PROJECT scope by the Regional Transportation Commission of Southern Nevada; and

WHEREAS, the CITY is a sub-recipient of federal transportation funds, Catalog of Federal Domestic Assistance (CFDA) Number 20,205 and the LOCAL AGENCY's Date Universal Numbering System (DUNS) Number 75288985 will be used for reporting purposes; and

WHEREAS, the Parties hereto desire to make certain amendments to Agreement No. P450-16-063.

NOW, THEREFORE, the Parties agree as follows:

- Attachment "A" is removed in its entirety and replaced with the attached Α. Attachment "A-1".
- Article I, Paragraph 3, is amended by deleting it in its entirety and inserting in its Β. place. "To obligate Federal CMAQ funding for a maximum amount of One Million Six Hundred Fifty Thousand and No/100 Dollars (\$1,650,000.00)."
- Article I, Paragraph 8, is amended by deleting it in its entirety and inserting in its C. place. "The DEPARTMENT shall issue such authorization through a written "Notice to Proceed". The "Notice to Proceed" will include the Federal Award Identification Number (FAIN) and the modified "project end date" mutually established by both parties in conformance with the requirements of 2 CFR Part 200."
- Article II, Paragraph 19, is amended by deleting it in its entirety and inserting in D. its place.

"To be responsible for the five percent (5%) match of Eighty-Six Thousand Eight

Hundred Forty-Two and No/100 Dollars (\$86,842.00) and for one hundred percent (100%) of all costs exceeding the obligated Federal funds. The CITY agrees the DEPARTMENT and the State of Nevada are not responsible for any costs exceeding the obligated Federal funds."

- E. Article II is amended by adding Paragraph 22 as follows, "To monitor compliance with subcontracting, prompt payments, and DBE requirements using B2GNow for tracking and reporting purposes and require contractors and subcontractors to use and submit documentation through B2GNow."
- F. / Article III, Paragraph 5, is amended by deleting it in its entirety and inserting in its place,

## Attachment A-1

## SCOPE OF WORK NORTH LAS VEGAS ITS PHASE 1

The project scope includes constructing incremental ITS infrastructure on <u>Centennial</u> Parkway from Camino Eldorado to Lamb Boulevard, Ann Road from Camino Al Norte to Losee Road and Aliante Parkway/Simmons Street from Elkhorn Road to Cheyenne Avenue. The ITS infrastructure includes constructing conduit along the roadway by trenching in the road or dirt areas outside the paved roadway or directional drilling. The project scope also includes installation of fiber optic pull boxes and vaults. Fiber Optic Cable (72-strand) will be installed within the mainline conduit and spliced to the Branch Fiber Optic Cable (12-strand) within conduit routed to the existing traffic signal controller cabinet. The Branch Fiber Optic Cable will be connected to an Ethernet Switch and CPU module to be installed within the existing traffic signal controller cabinets. The project scope also includes the purchase of fiber optic network monitoring software to support the new system.
