STAFF COMMENTS AND BACKGROUND INFORMATION:

Council previously approved the acceptance and expenditure of JAG Funds for technology related purchases for targeted projects to enhance criminal justice within the Police Department on September 2, 2020. The Agreement was signed based on the September 2, 2020 approval; however, the selection of Teledata as the vendor had not been previously approved by Council. Therefore, Staff is presenting this Agreement to Council for approval of the purchase with Teledata as a housekeeping measure.

The purchase agreement funded through JAG Funds that will provide the Police Department with cameras and associated equipment in the Northwest Area Command, South Area Command, and Mobile Command facilities.
