STAFF COMMENTS AND BACKGROUND INFORMATION:

Through years of required maintenance activities within and around City owned infrastructure located not only within the limits of the City of North Las Vegas, but also in Clark County, City of Las Vegas, and Nevada Department of Transportation, the street alignment where such facility is situated has deteriorated, potentially creating a safety hazard, needing remediation.

This three (3) year on call Clark County Prevailing Wage Project will address these roadway deficiencies that generally consists of asphalt patching, repair, and reconstruction as needed. The specific nature of the work and duration thereof will be site specific.

On June 29, 2021, two (2) bids were opened for the Intersection and Roadway Improvements FY 20 Service Contract of \$3,106,531.90 and \$7,346,650.00. CG&B Enterprises Inc. submitted the lowest responsive and responsible bid of \$3,106,531.90.

CG&B Enterprises Inc., along with their proposed subcontractor (X-2 LLC) possess the proper license to perform the work. In addition, the Contractors possess adequate staff and equipment to complete the work.

Construction management duties will be performed by City personnel.
