STAFF COMMENTS AND BACKGROUND INFORMATION:

The purpose of the project, is to support the expansion of the existing ViPS program of Volunteer Officers within the City through assisting with outreach to community organizations to maximize community relations while supporting the patrol functions. Additionally, the project is intended to provide NLVPD law enforcement officers additional de-escalation scenario based training to support their mission, goals, close the gap in de-escalation preparedness while enhancing the safety and outcomes for both police officers and members of the community as they interact with each other through the line of duty. The system and headsets will provide interactive testing/assessment and a true-to-life training environment with scenario-based exercises for both the Trainer and Trainee to increase knowledge and skill retention as part of annual de-escalation training for all NLVPD Officers.
