#### 3. Update on Seastrand Park - Sports Art Project. (For Discussion Only)

Recreation Supervisor said an order was placed for six ballard balls to be placed in the circle at Seastrand Park. She added the project will start in about four to six weeks.

#### 4. Receive Staff Update on Electrifying Art Project. (For Discussion Only)

Recreation Supervisor Johnson said the first community meeting will be January 5, 2022 and all the high school artist are invited and will be held at the Neighborhood Recreation Center. She said artists will be able to ask questions and will be given the expectations. She added they will have a month to turn in their proofs for approval before they can move forward with their art project.

# 5. Discussion on Mural at Neighborhood Recreation Center - Community Partnership. (For Discussion Only)

Recreation Supervisor Johnson partnered with graffitipark.org and will be painting a mural at the Neighborhood Recreation Center at the front and side of the building. She said this will be a community project and will be inviting anybody willing to participate. She added that this project should be completed at the end of the year. Members of graffitipark.org is scheduled to meet with her team tomorrow to discuss ideas and will submit them by the end of month.

In response to Member Lisiewski, Recreation Supervisor Johnson said that graffitipark.org is the organization that painted the YMCA.

In response to Chairman Branch, Recreation Supervisor Johnson said there is a problem with tagging but is hoping they will take pride in this because this is a community project. She added that the co-founder of Graffittiparks.org said there is an artist agreement – when an artist puts up art, others will not tag it. She said that nobody has tagged the utility boxes yet and is hoping that it will be left alone.

#### STAFF ITEMS

Assistant Manager Melesio introduced Douglas Guild as the new Deputy Director of Neighborhood and Leisure Services. Deputy Director of Neighborhood and Leisure Services Guild gave a brief introduction of himself.

Library Director Forest Lewis and Public Information Officer Linda Bridges spoke on an art idea and is looking to have the PARCAB members participate. He explained there are three libraries with book drop locations and is looking to add artwork to the boxes. Director Lewis said there would be different artists at each library. Director Lewis said he is looking to have PARCAB members help run the contest and Library District would be in charge of getting the winning art wrapped for the drop boxes. He added that he would like to meet at a future meeting to discuss more details.

In response to Vice Chairwoman Ward, Director Lewis said it would be ideal if the artists would be a North Las Vegas resident and it should not be a problem finding any. He added that if there are not enough responses from residents, then he would look outside the City of North Las Vegas.

In response to Member Brown, Director Lewis said at this time only the two book drops that are at each location. He added with the success of this program, more artwork will expand.

Member Hiller gave an art experience she had at a Las Vegas-Clark County Library District. Director Lewis said eventually artwork will be displayed inside the libraries.
