**STAFF COMMENTS AND BACKGROUND INFORMATION:**

The City of North Las Vegas is developing its 2022/2023 Annual Action Plan (AAP) for Community Development Block Grant (CDBG) and Emergency Solutions Grant (ESG) funds. The purpose of this Action Plan is to identify the City's housing and community development needs, priorities, goals, and strategies and to stipulate how funds will be allocated to housing and community development activities during the 20/22/2023 program year. The Action Plan details how funds will be spent in the program year.

Once the public hearing has been held to allow for public comments on the Action Plan it must then be approved by City Council once the public comment period has expired. Following City Council approval, the Plan will be submitted to the U.S. Department of Housing and Urban Development (HUD) for review and acceptance. The draft Plans are available for public review and comment from April 1 through April 30, 2022 as the "Draft 2022 Action Plan" via the City's website at the following URL listed within the document on that page:
