RESOLUTION NO. 2690

A RESOLUTION OF THE NORTH LAS VEGAS CITY COUNCIL ADOPTING FINDINGS REGARDING UTILIZATION OF REVENUE GENERATED BY THE CLARK COUNTY CRIME PREVENTION ACT OF 2016.

WHEREAS, the Nevada Legislature passed The Act at the 30th Special Session of the Nevada Legislature, which authorized the Board of County Commissioners of Clark County, Nevada, to increase the sales and use tax for the purposes of employing and equipping additional police officers for police departments located within Clark County, including the North Las Vegas Police Department (the "Clark County Crime Prevention Act of 2016" or "Act");

WHEREAS, on November 15, 2016, the Board of County Commissioners of Clark County, Nevada, held a public hearing to present its plan for implementation of the proposed tax, and adopted Ordinance No. 4447 to impose such tax to be effective on April 1, 2017;

WHEREAS, on February 28th 2017, the City of North Las Vegas created a Crime Prevention Special Revenue Fund to account for the revenues received that are designated to be used to employ and equip additional police officers for the City and was adopted May 17th 2017 in the 2018 Budget;

WHEREAS, the Act prohibits the use of revenue generated by the tax to replace or supplant existing funding for police departments;

WHEREAS, the Act requires the North Las Vegas City Council ("City Council") to make certain determinations and findings consistent with requirements of the Act before it can approve an expenditure of money allocated to the North Las Vegas Police Department ("NLVPD") from the proceeds of the tax;

WHEREAS, the City Council desires to make certain findings and determinations in accordance with the Act for the fiscal year 2022-23 ("FY 2023");

NOW, THEREFORE, BE IT RESOLVED by the North Las Vegas City Council:

Section 1. In accordance with the provisions of the Act, the City Council does hereby determine and find as follows:

- A. The proposed use of the money conforms to all provisions of the Act;
- B. The proposed use of the money will not replace or supplant existing funding for the NLVPD.
 - i. This determination is supported by the finding that the amount approved for expenditure by the City Council for the General Fund support of the NLVPD for FY 2023, not including any money allocated to or expended by the NLVPD pursuant to the provisions of the Act, is

\$58,387,560 or 10.81% greater than the General Fund amount approved for expenditure for the support of the NLVPD in the immediately preceding fiscal year.

- ii. The following reason support the findings set forth above:
 - a. The General Fund expenditure budget of the NLVPD increased by \$5,695,886 or 10.81% from the FY 2022 Final Budget to the FY 2023 Final Budget.
- C. The proposed use of the money will not be the payment of salary or any increase in salary for any person who is employed by the NLVPD before October 1, 2016; and
- D. The proposed use of the money is based upon a consideration of the distribution of the population within the area of the City of North Las Vegas served by the NLVPD and the distribution of calls for service within the area of the City of North Las Vegas served by the NLVPD.
