STAFF COMMENTS AND BACKGROUND INFORMATION:

The City of North Las Vegas Charter Committee was created by City Council on 5/4/22 through Resolution No. 2692 and will review the North Las Vegas City Charter and advise City Council of its recommendations regarding any necessary amendments to the Charter. This committee was made in response to AB55 passed by the Nevada Legislature during the 2021 Legislative Session

Pursuant to Section 3 of the bylaws, the Committee shall be comprised of thirteen (13) members who are appointed as follows:

- 1. The Mayor shall appoint two (2) members;
- 2. The Mayor pro tempore shall appoint two (2) members;
- 3. The remaining members of the City Council shall each appoint one (1) member;
- 4. The members of the Senate delegation representing the residents of the City and belonging to the majority party of the Senate shall appoint two (2) members;
- 5. The members of the Senate delegation representing the residents of the City and belonging to the minority party of the Senate shall appoint one (1) member;
- 6. The members of the Assembly delegation representing the residents of the City and belonging to the

majority party of the Assembly shall appoint two (2) members; and

7. The members of the Assembly delegation representing the residents of the City and belonging to the minority party of the Assembly shall appoint one (1) member.

Members appointed to the Committee must be registered voters of the City and must reside in the City during his or her term of office. The terms of each member shall commence at the first Charter Committee meeting following appointment and are concurrent with the term of the person or persons, as applicable, by whom the member was appointed. If the term of office of any person making an appointment ends by resignation or otherwise, the term of office of a member of the Charter Committee appointed by that person ends on the day that the person resigns or otherwise leaves office.

The Charter Committee must meet at least once every even numbered year on the fourth Monday in June and make recommendations to City Council on any proposed Charter changes prior to the start of the next Nevada Legislative Session.
