The Planning Commission unanimously (7-0 vote) approved ZOA-03-2022 at their meeting on June 8, 2022. Sections 2, 4, 5, 6, and 7 of ZOA-03-2022 are contained in Ordinance No. 3131.

With Ordinance No. 3131, the City is proposing numerous amendments to Title 17, the Zoning Code. The major change in Ordinance No. 3131 is a modification to the parking standards for recreational vehicles in residential setbacks. Other minor changes clarify or correct incorrect references in the code.
