SUPPLEMENTAL INTERLOCAL CONTRACT NO.1 RTC TRAFFIC SIGNAL PROGRAM MANAGEMENT

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO.1 is made and entered into this 14TH day of July 2022, by and between Clark County, a political subdivision; the City of Las Vegas, a municipal corporation; the City of North Las Vegas, a municipal corporation; the City of Henderson, a municipal corporation; the City of Boulder City, a municipal corporation; and the City of Mesquite, a municipal corporation; hereinafter referred to individually as "ENTITY" or collectively as "ENTITIES," and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as "RTC." The RTC and the ENTITIES are hereinafter referred to individually as "PARTY" or collectively as "PARTY" or collectively as "PARTY" or collectively as "PARTIES."

WITNESSETH

WHEREAS, the RTC approved Interlocal Contract 1317 dated September 9, 2021, and for improvements to RTC – Traffic Signal Program Management, hereinafter referred to as "PROJECT," located wholly within Clark County, City of Las Vegas, City of Henderson, City of North Las Vegas, City of Boulder City, and City of Mesquite and

WHEREAS, Nevada Revised Statutes (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the ENTITIES agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

WHEREAS, the RTC wishes to increase total project funding and extend the project completion date; and

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the Parties hereto, the Parties agree to proceed as follows:

SECTION II: PROJECT COSTS; Paragraph 1 and 2 shall be revised to read as follows

- 1. The total cost for this contract shall not exceed \$650,000.00.
- 2. Authorizations to Proceed (ATP) are granted as follows:
 - a. ENGINEERING not to exceed \$650,000.00
 - b. RIGHT-OF-WAY not to exceed \$0.00
 - c. CONSTRUCTION not to exceed \$0.00

SECTION III: GENERAL; Paragraph 2 shall be revised to read as follows

2. The PROJECT must be completed to the satisfaction of the RTC prior to the current

applicable completion date of December 31, 2027. The RTC may, at any time thereafter, grant time extensions or terminate this Contract and require all sums advanced to the CITY be repaid.

The remainder of Interlocal Contract 1317 dated September 9, 2021, shall remain unchanged.
