STAFF COMMENTS AND BACKGROUND INFORMATION:				
Currently, there is a shortage of multi-use sports fields throughout the City of North Las Vegas which has				

Currently, there is a shortage of multi-use sports fields throughout the City of North Las Vegas which has struggled to meet the growing needs of residents of all ages who wish to engage in sports activities including soccer, lacrosse, flag and tackle football, and rugby. Additionally, the sports fields that the City does offer are spread throughout the City, which makes it difficult for staff and outside organizations to host large-scale tournaments and training camps. This has affected the revenue stream for the Sports division, as there are not enough fields to satisfy league and allocations needs.

The installation of these multi-use fields will almost double the City's current inventory, allowing City residents access to play spaces that they have had to travel outside the City for in the past. Also, this complex will serve as the first facility within the City that will be able to host large-scale tournaments. As a result of these additional fields, City staff will be able to run additional leagues, host tournaments, and increase allocations, resulting in a substantial increase in revenue.

Concurrent with the installation of these sports fields, the construction of the associated amenities (restrooms, concessions, play areas, access roads) will bring these necessary components to an area of the park which is lacking these amenities, thereby expanding the usable and accessible acreage of the regional park.
