RECOMMENDATION OR RECOMMEND MOTION:

It is recommended that City Council approve amendments to the fiscal year 2019-2020 Annual Action Plan including the allocation of \$1,459,052 in Community Development Block Grant - COVID 3 (CDBG-CV3) funds to three activities; \$857,800 to mortgage assistance, \$309,442 to food services, and \$291,810 to administration; and the allocation of \$3,071,445 in Emergency Solution Grant - COVID2 (ESG-CV2) to four Activities; \$500,000 to CNLV street outreach, \$1,000,000 to rapid re-housing, \$1,264,300 to homeless prevention, and \$307,145 to administration; and Authorize the City Manager or his designee to enter into appropriate agreements of approved programs and projects as required and administratively approve any revised final funding allocations or contract amendments as needed.
