ORDINANCE NO. 3038

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF NORTH LAS VEGAS, NEVADA TO AMEND CHAPTER 13.24 OF THE NORTH LAS VEGAS MUNICIPAL CODE TO MAKE VARIOUS CHANGES RELATIVE TO DEFINITIONS AND FEES AND PROVIDE FOR OTHER MATTERS PROPERLY RELATED THERETO.

THE CITY COUNCIL OF THE CITY OF NORTH LAS VEGAS, NEVADA, DOES ORDAIN:

<u>SECTION 1</u>: Section 13.24.010 of the North Las Vegas Municipal Code (NLVMC) is hereby amended by adding and inserting in the alphabetically appropriate place the following definition:

"Supplemental Losee Road Sewer Connection Fee" means a charge to be made, in addition to all other fees, to any user benefiting from and contributing wastewater to the Losee Road Sewer upstream of the intersection of Losee Road and Mendenhall Road.

<u>SECTION 2</u>: Chapter 24 of Title 13 of the NLVMC is hereby amended by adding a new section 130 as follows:

13.24.130 – Service Rules and Regulations.

The Director or designee shall adopt, add to, delete, interpret, modify and enforce the service rules and regulations pertaining to the operations and policies of the North Las Vegas sewer system.

<u>SECTION 3</u>: Section 13.24.070 of the NLVMC is hereby amended by adding a new paragraph H as follows:

- H. Supplemental Losee Road Sewer Connection Fee
 - Any customer benefitting from and contributing wastewater to the Losee Road Sanitary Sewer upstream of the intersection of Losee Road and Mendenhall Road shall be charged a supplemental Losee Road Sewer Connection Fee of \$354.00 per equivalent residential unit (ERU) based on the total fixture units as calculated pursuant to Section 13.24.070, Paragraph A in addition to all other fees. Fee is due and payable at the same time the sewer connection permit is issued.

SECTION 4: NON-INFRINGEMENT OF RIGHTS. The City Council of the City of North Las Vegas has been informed by the City Attorney as to the constitutionality of this ordinance and based upon such information we are adopting this ordinance in good faith with a reasonable belief that the actions taken by the City of North Las Vegas are not in violation of any rights, privileges or immunities secured by the laws providing for equal rights of citizens or persons.

SECTION 5: EFFECTIVE DATE. This ordinance shall become effective after its passage by the City Council of the City of North Las Vegas, and after such passage by the City Council, publication once by title in a newspaper qualified pursuance to the provisions of Chapter 238 of the Nevada Revised Statutes, as amended from time to time.

SECTION 6: PUBLICATION. The City Clerk shall cause this ordinance, immediately following its adoption, to be published once by title, together with names of the council members voting for or against passage, in a newspaper qualified pursuant to the provisions of Chapter 238 of the Nevada Revised Statutes, as amended from time to time.
