## SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2 TROPICAL PARKWAY/LINN LANE, EL CAMPO GRANDE AVENUE TO CC-215

WHEREAS, RTC approved an interlocal contract on February 12, 2015, and Supplemental Interlocal Contract No. 1 on March 10, 2016 for a project to construct roadway widening improvements along Tropical Parkway, provide a connection from Tropical Parkway to CC-215 and improve the Linn Lane alignment to El Campo Grande Avenue, hereinafter referred to as "PROJECT," located wholly within the City of North Las Vegas, has been approved by the RTC; and;

WHEREAS, the RTC previously granted "Authorization to Proceed" for construction, engineering and right-of-way other; and

WHEREAS, the CITY desires to extend the project completion date; and

**NOW THEREFORE**, in consideration of the covenants, conditions, agreements and promises of the Parties hereto, the Parties agree to proceed as follows:

## SECTION III - GENERAL; shall be changed to read as follows:

6. The PROJECT must be completed to the satisfaction of the RTC prior to the current applicable completion date of March 31, 2019. The RTC may, at any time thereafter, grant time extensions or terminate this Contract and require all sums advanced to the CITY be repaid.

The remainder of the interlocal contract dated February 12, 2015 and the supplemented on March 10, 2016 shall remain unchanged.
