STAFF COMMENTS AND BACKGROUND INFORMATION:

On September 19, 2012, City Council approved a Cooperative Agreement with NDOT in the amount of \$567,800 for the construction of the Cheyenne Avenue at MLK Drive Intersection Improvements Project. This project consists of the construction of the dedicated right turn lane at the southwest corner of the intersection of Cheyenne Avenue and Martine Luther King Boulevard.

On December 12, 2012, City Council approved Amendment No. 1 with NDOT for a federally mandated 5% match, increasing the total NDOT contract to \$597,684 for this project.

On October 1, 2014, City Council approved Amendment No. 2 with NDOT for a federally mandated 5% match, increasing the total NDOT contract to \$892,211 for this project.

On October 5, 2016, City Council approved Amendment No. 3 with NDOT increasing the total NDOT contract total for this Project to \$955,369.

On December 5, 2018, City Council approved Amendment No. 4 with NDOT extending the project completions date from January 31, 2019 to June 30, 2022.

Amendment No. 5 will extend the project completion date from June 30, 2022 to June 30, 2024, increase the NDOT total contract amount to \$1,265,895, and revise the project scope to include an installation of a dedicated eastbound right turn lane for Cheyenne Avenue at the Martin Luther King Boulevard intersection.
