ORDINANCE NO. 3069

AN ORDINANCE RELATED TO ZONING; RECLASSIFYING APPROXIMATELY 8.87± ACRES IN THE ZONING MAP OF NORTH LAS VEGAS FROM AN O-L, OPEN LAND DISTRICT TO AN M-2, GENERAL INDUSTRIAL DISTRICT (ZN-02-2021, TROPICAL SPEEDWAY COMMERCE CENTER II) FOR PROPERTY LOCATED AT THE NORTHWEST CORNER OF TROPICAL PARKWAY AND BEESLEY DRIVE AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

WHEREAS, the rezoning is consistent with the Comprehensive Plan; and

WHEREAS, the Council determines that the amendment will not adversely affect the health and general welfare; and,

WHEREAS, according to Paragraph B of Section 70 of Chapter 12 of Title 17 of the North Las Vegas Municipal Code, the City Council may, by ordinance, reclassify property.

NOW THEREFORE, the City Council of the City of North Las Vegas does ordain:

SECTION 1: In accordance with the provisions of Ordinance No. 3069, the following described parcel of land shall be reclassified as follows:

FROM O-L, OPEN LAND DISTRICT, TO M-2, GENERAL INDUSTRIAL DISTRICT (ZN-02-2021), THE FOLLOWING PROPERTY DESCRIBED TO WIT:

LOCATED WITHIN THE SOUTHEAST QUARTER (SE 1/4) OF THE SOUTHWEST QUARTER (SW 1/4) OF THE NORTHWEST QUARTER (NW 1/4) OF SECTION 27, TOWNSHIP 19 SOUTH, RANGE 62 EAST, M.D.M., CITY OF NORTH LAS VEGAS, CLARK COUNTY, NEVADA.

COMMENCING AT THE WEST SIXTEENTH CENTER SECTION CORNER OF SAID SECTION 27, BEING THE CENTERLINE INTERSECTION OF TROPICAL PARKWAY AND BEESLEY DRIVE; THENCE NORTH 87°07'03" WEST ALONG THE CENTERLINE OF SAID TROPICAL PARKWAY, 52.90 FEET; THENCE NORTH 02°52'57" EAST DEPARTING SAID CENTERLINE, 40.00 FEET TO THE NORTHERLY RIGHT-OF-WAY OF SAID TROPICAL PARKWAY, BEING THE **POINT OF BEGINNING**;

THENCE NORTH 87°07'03" WEST, 573.12 FEET TO THE BEGINNING OF CURVE CONCAVE NORTHEASTERLY HAVING A RADIUS OF 20.00 FEET; THENCE NORTHWESTERLY, 30.54 FEET ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 87°29'03"; THENCE NORTH 00°22'00" EAST, 614.06 FEET; THENCE SOUTH 87°00'15" EAST, 611.13 FEET; THENCE SOUTH 00°10'17" WEST, 611.12 FEET TO THE BEGINNING OF CURVE CONCAVE NORTHWESTERLY HAVING A RADIUS OF 20.00 FEET; THENCE SOUTHWESTERLY, 32.36 FEET ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 92°42'40" TO THE **POINT OF BEGINNING**, AS SHOWN ON THE "EXHIBIT TO ACCOMPANY LEGAL DESCRIPTION" ATTACHED HERETO AND MADE A PART HEREOF.

CONTAINING 8.87 ACRES, MORE OR LESS, AS DETERMINED BY COMPUTER METHODS.

SECTION 2: The General Industrial District (M-2) herein is subject to the development standards and requirements of the North Las Vegas Municipal Code.

SECTION 3: NON-INFRINGEMENT OF RIGHTS. The City Council of the City of North Las Vegas has been informed by the City Attorney as to the constitutionality of this ordinance and based upon such information we are adopting this ordinance in good faith with a reasonable belief that the actions taken by the City of North Las Vegas are not in violation of any rights, privileges, or immunities secured by the laws providing for equal rights of citizens or persons.

SECTION 4: SEVERABILITY. If any section, paragraph, clause or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall in no way affect the validity and enforceability of the remaining provisions of this Ordinance.

SECTION 5: EFFECTIVE DATE. This Ordinance shall become effective after its passage by the City Council of the City of North Las Vegas and, after such passage by the City Council, publication once by title in a newspaper qualified pursuant to the provisions of Chapter 238 of NRS, as amended from time to time.

SECTION 6: PUBLICATION. The City Clerk shall cause this Ordinance, immediately following its adoption, to be published once by title, together with the names of the Councilmen voting for or against passage, in a newspaper qualified pursuant to the provisions of Chapter 238 of NRS, as amended from time to time.
