STAFF COMMENTS AND BACKGROUND INFORMATION:

The City of North Las Vegas has developed its Fiscal Year 2021-2022 Housing & Urban Development (HUD) Annual Action Plan as a direct Entitlement Community for Community Development Block Grant (CDBG) and Emergency Solutions Grant (ESG) funds. Annually, recipients of HUD block grant funds must prepare an Annual Action Plan that details how funds will be spent for that program year. The purpose of the 2021-2022 Action Plan is to identify the City of North Las Vegas housing and community development needs, priorities, goals, and strategies, and to stipulate how funds will be allocated to housing and community development activities during Fiscal Year 2021-2022. The public comment period for the Fiscal Year 2021-2022 Annual Action Plan was from April 1, 2021 through April 30, 2021. The public hearing to receive comments on the Action Plan was held on April 21, 2021. Any comments received at the public hearing or during the public comment period have been incorporated into the Action Plan. Once approved by City Council, the Action Plan will be submitted to HUD for acceptance prior to May 15, 2021.
