3. <u>RATIFY GRANT APPLICATION FOR LSTA MINI GRANT, IN THE AMOUNT</u> OF \$6,350.00 (FOR POSSIBLE ACTION)

Library Director Lewis stated that this was a small grant which the department applied for and was able to obtain additional funds from it. He stated that the application amount is typically \$3,000 for the reading program. However, this year the application format was different, which allowed for the department to apply for the grant throughout the year. This new process also allowed for the department to apply for additional funds throughout the year. These funds will specifically be used for the reading program as follows.

- \$1,000 Collection Development (books and materials).
- \$825.00 for adult program materials.
- \$1,000 for the Grab and Go Activity Kits.
- Remaining funds for performances in the library such as music together, magic shows and partnering engineering for kids.

In addition, he mentioned that some local businesses provide reading incentives for students.

Library Director Lewis answered trustee King's question regarding the timeline for students to be able to participate in the program. He stated that the program the department uses is called Beanstalk, where students can register. This allows students to attend the program without having to come into the library. During the months of June and July, students and adults can register to keep track of completed reading hours. After successfully completing a certain number of hours, students and adults are able to win prizes and enter into additional prize drawings. However, the only time students or adults come to the library is when they are attending a magic show. There is no time commitment for this program; the intent is to get students and families involved.

Library Director Lewis answered Trustee Lockhart's question regarding this issue that also involved the Aliante, Alexander and North Las Vegas libraries. He stated that it does involve all three libraries. There will be programs in all locations and all students will be able to enroll through the Beanstalk website.

Library Director Lewis answered Trustee Henry's question regarding additional information. He stated that he will provide all the information for this program at a later meeting. He also stated that the grant funds could be used for promotions, programming, and collective development. However, the funds cannot be used for incentive prizing. The department reaches out to local businesses that provide reading incentives for students.

4. <u>APPROVE NORTH LAS VEGAS LIBRARY DISTRICT STRATEGIC PLAN</u> (FOR POSSIBLE ACTION).

Library Director Lewis stated that the strategic plan is the same plan that was presented at the last meeting by Planning Consultant Futterman. This agenda item was the proofing of the strategic plan. Once the strategic plan is approved, the department will be submitting the plan to the Nevada State Library since it is a requirement. He also stated that he wanted to make the Trustees aware that he is working with Mr. Futterman on an item that is not directly tied to this strategic plan. The project is to demonstrate future library services. This will allow the department to be ahead of the curve and meet the needs of the community as it grows.

Library Director Lewis answered Trustee King's question regarding a three-year data visitation of the strategic plan to determine the pathway for years four and five. He stated that the information was correct and that the department does continue to verify and ensure that the guidelines are being followed.

5. <u>RATIFY GRANT APPLICATION FOR LSTA ARP, IN THE AMOUNT OF</u> \$50,000.00 (FOR POSSIBLE ACTION)

Library Director Lewis stated that this grant, American Rescue Plan, and the department is looking to use the funds. He stated that the service they use for digital books is called OverDrive. This program is shared with the Las Vegas Clark County Library District and they have a partnership with the Clark County School District. The Las Vegas Clark County Library District transferred young adult titles over to a program called Axis 360, which the North Las Vegas Library does not have access to. As a result, members of the North Las Vegas Library lost access to these fictional and nonfictional digital books. Library Director Lewis stated that with the partnership they have with the Overdrive system, they have access to adult books and are unable to use that database to order or access children's books. He is suggesting that they create an opening day collection of young adult books with the grant, they are asking for \$50,000 in grant funding, and they will be adding \$20,000 from the Library District Collection fund to purchase additional titles. At an average of \$20.00 per digital book, they would gain access to 3,500 digital books and be able to gain more as the year's progress. This would also encourage students that do not want to visit a library but would like to read books digitally.

Library Director Lewis responded to Chairman Henry's question by stating that they will have both, fiction and non-fiction digital books available. He also stated that there will be a variety of digital books for all age groups.

Library Director Lewis responded to Trustee King's guestion by stating that nonfictional digital books such as academic space, stem programing, introduction of coding and work/school ready programs will be available for students as well. He also stated that in the future there will also be an option to purchase the books in physical form. Library Director Lewis mentioned that the program Axis 360 is tied in with a company called Baker & Taylor, which is the company the department uses to obtain their physical books. Baker & Taylor are tied in with all major book vendors, which allows the department to have access to many books. In addition, Library Director Lewis states that the department is looking into a program where members can check out titles for a fee instead of purchasing the book for a full price. This will allow members to have a broader access to the digital collection. Library Director Lewis responded to Trustee King's question regarding individuals that may not have the financial needs to pay for their fines. He stated that unfortunately, the grant money cannot be used to create an emergency fund grant to help individuals pay for fines they have acquired. He also stated that the department has ways that they can work with individuals that owe fines as well as other resources to help them financially.

Library Director Lewis responded to Chairwoman Henry's question by confirming that \$20,000 will be used from the department's collection to purchase more titles. He also mentioned that \$50,000 would be coming from the LSTA ARP.

6. <u>RATIFY GRANT APPLICATION FOR ALA NEH ARP, IN THE AMOUNT OF</u> \$10,000.00 (FOR POSSIBLE ACTION)

Library Director Lewis stated that this is a grant that the department applied for. He stated that the City of North Las Vegas has a grant department that assists in obtaining and applying for available grants. He stated that it really helps the department discover new available grants. The Humanities grant, which is applied directly through the American Library Association and it is part of the American Rescue Plan dollars. This grant will help fulfill something the department has been looking into for some time. Library Director Lewis states that the small meeting room in the Aliante Library was

originally designed as an art display space. However, because of the demand for meeting rooms, that space was not able to be utilized to display art. The grant funds will be used as follows:

- \$3,000 for a wall-hanging cable system to display and rotate the art.
- \$3,000 to purchase a glass display case for the art that cannot be placed on the wall.
- \$2,500 will be used towards cultural programming and receptions for art work.
- \$1,000 will be used for promotional campaigns.

Library Director Lewis answered Trustees Powers question by stating that he will provide the acronyms for the alphabet written out for the Trustees.

The Chromebooks will be cataloged and will have data services that do not contain a cap. Students and adults will be able to check out the Chromebook for school or job searches. The Chromebooks will become available within the next two weeks.
