2. <u>JUNE 14, 2022 MUNICIPAL PRIMARY ELECTION RESULTS. (CITYWIDE)</u> (FOR POSSIBLE ACTION; RECOMMENDATION - APPROVE)

City Clerk Jackie Rodgers stated the early voting period for the 2022 Primary Election began on Saturday, May 28, 2022 and concluded on Friday, June 10, 2022. She said during that period, the City Clerk's Office monitored the Mail Ballot drop box situated in the Planning and Zoning area of City Hall on the first floor. City Clerk Rodgers said the Mail Ballot drop box was monitored at all times and never left alone. She stated as a matter of process, the clerk would verify that ballots were signed prior to being dropped in the box. She said she could attest to the integrity of the contents of the drop box to the point that it was picked up by the Clark County Elections Department and was no longer under the care of the City Clerk's Office. City Clerk Rodgers stated the drop box was picked up daily between 5:00 p.m. and 5:45 p.m. by the Elections Department. She said for the 2022 Primary Election, there were a total of 142,340 registered voters in the city and a breakdown of each race was before Council. City Clerk Jackie Rodgers said with that, she recommended the City Council approve the June 14, 2022 Primary Election results.

Councilwoman Goynes-Brown thanked City Clerk Rodgers and asked if there were any additional comments.

Councilman Barron thanked Councilwoman Goynes-Brown and stated he was looking at the letter from the Registrar of Voters, Joe Gloria. He said there were only 15 errors and that was less than one percent. He said he was happy that he lived in a country which had fair, free and very accurate elections. Councilman Barron stated it was dynamic to be a part of the system and involved in the experiment of republican democracy. He said he would allow Councilman Goynes-Brown to make the motion to approve the item.

Mayor Pro Tempore Cherchio stated he echoed Councilman Barron's sentiments.

Councilman Black stated he had no comment.
