INTERLOCAL CONTRACT ENTITY NON-PROJECT SPECIFIC EXPENSES CITY OF NORTH LAS VEGAS FISCAL YEAR 2022-2026

THIS INTERLOCAL CONTRACT is made and entered into this 8TH day of July 2021, by and between the City of North Las Vegas, a municipal corporation, hereinafter referred to as "CITY" and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as "RTC."

WITNESSETH

WHEREAS, a contract to enable the CITY to be reimbursed the cost of work related to RTC issues that are not attributable to a specific project has been approved; and

WHEREAS, it is desired that the CITY utilize this reimbursement to expedite RTC roadway projects; and

WHEREAS, Nevada Revised Statue (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the CITY agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the Parties hereto, the Parties agree to proceed as follows:

SECTION I: SCOPE OF PROJECT

This Interlocal Contract applies to the reimbursement of expenses incurred by the City of North Las Vegas during work on Regional Transportation Commission of Southern Nevada issues that are not attributable to a specific project.

SECTION II: PROJECT COSTS

The RTC agrees to provide funding for all costs associated with the PROJECT from the Highway Improvement Acquisition Fund as outlined below:

- 1. The total cost for this contract shall not exceed \$50,000.00.
- 2. Authorizations to Proceed (ATP) are granted as follows:
 - a. ENGINEERING not to exceed \$50,000.00
 - b. RIGHT-OF-WAY not to exceed \$ 0.00
 - c. CONSTRUCTION not to exceed \$ 0.00
- 3. The work shall be performed by the CITY's employees for work on RTC issues that are not attributable to a specific project.

- 4. Copies of time sheets showing the RTC street and highway projects or program development activities must be submitted with each invoice.
- 5. Employee's expenses for work on non-RTC street and highway activities or issues are not reimbursable.
- 6. All records pertinent to RTC reimbursable costs are subject to audit at RTC's request.
- 7. A supplemental interlocal contract will be required for any changes to the amounts identified in number 2 above.
- 8. The RTC agrees to reimburse costs incurred on or after July 1, 2021.

SECTION III: GENERAL

- 1. Typical activities that are included in this program include preparation of agenda items, capital improvements programs, final reports and attendance of RTC meetings.
- 2. Employment requirements and hiring procedures will be determined by the CITY.
- 3. All costs shall be reimbursed directly to the CITY.
- 4. It is understood and agreed that the purpose of this Interlocal Contract is to fund the reimbursement as hereinabove set forth.
- 5. The PROJECT must be completed to the satisfaction of the RTC prior to the current applicable completion date of June 30, 2026. The RTC may, at any time thereafter, grant time extensions or terminate this Contract and require all sums advanced to the CITY be repaid.
