## SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2 LAKE MEAD BOULEVARD SIMMONS STREET TO LOSEE ROAD

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2 is made and entered into this 14<sup>TH</sup> day of July 2022, by and between the City of Las Vegas, a municipal corporation, hereinafter referred to as "LAS VEGAS," City of North Las Vegas, a municipal corporation, hereinafter referred to as "NORTH LAS VEGAS," and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as "RTC."

## WITNESSETH

WHEREAS, the RTC approved Interlocal Contract 1081 dated May 23, 2019, and supplemental interlocal contract dated March 11, 2021, for improvements to Lake Mead Boulevard, Simmons Street to Losee Road, hereinafter referred to as "PROJECT," located partially within the City of Las Vegas and partially within City of North Las Vegas; and

WHEREAS, Nevada Revised Statutes (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the CITY agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

WHEREAS, Las Vegas will coordinate with and include North Las Vegas during design and construction

WHEREAS, Las Vegas will take the lead role for the design and construction of the PROJECT; and

WHEREAS, the CITY wishes to extend the project completion date; and

**NOW, THEREFORE**, in consideration of the covenants, conditions, agreements, and promises of the PARTIES hereto, the PARTIES agree to proceed as follows:

## SECTION III: GENERAL; paragraph 6 shall be revised to read as follows:

6. The PROJECT must be completed to the satisfaction of the RTC prior to the current applicable completion date of December 31, 2027. The RTC may, at any time thereafter, grant time extensions or terminate this Contract and require all sums advanced to the CITY be repaid.

The remainder of Interlocal Contract 1081 dated May 23, 2019, and supplemental interlocal contract dated March 11, 2021, shall remain unchanged.
