## STAFF COMMENTS AND BACKGROUND INFORMATION:

EXPLANATION: Funds from sale to be deposited into Redevelopment

The North Las Vegas Redevelopment Agency (Agency) intends to sell 0.51 acres of real property commonly known as APN 139-23-201-020 and generally located north of the intersection of Las Vegas Blvd. N. and N. Bruce St. in the Downtown Redevelopment Subdistrict (Property) to 2113 Investors, LLC, a Nevada limited-liability company (Purchaser), for \$250,000.00. The Property is located adjacent to Purchasers existing property located at 2113 Las Vegas Boulevard, North and the Property will be incorporated into and become part of Purchasers 2113 Las Vegas Boulevard, North site.

NRS 279.630(3) requires that the sale of any property acquired in whole or in part from redevelopment funds be approved by the City Council by resolution adopted after a public hearing. A notice related to the public hearing and City Council resolution approving the proposed sale of the Property by the Agency was published in the Las Vegas Review Journal on August 10, 2022. If City Council approves Resolution No. 2698, the Agency will conduct a public hearing on its intent to sell the Property at the Agency meeting on September 7, 2022. Following the public hearing, Agency will consider approving the Purchase and Sale Agreement with Purchaser at that same Agency meeting on September 7, 2022.
